## Pioneer Announces Change of President

The board of directors of Pioneer Corporation, at its meeting held on May 14, 2018, resolved that Mr. Susumu Kotani, currently Representative Director, President and CEO, would become Director and Chairman Executive Officer, and Mr. Koichi Moriya, currently Director and Senior Executive Officer, would become Representative Director, President and CEO, effective as of June 27, 2018.
